The designated times of care are structured by you and allow an individualization of supervision time allowing your child to attend for example, music lessons or sport training programmes. The official duty of care remains with the school staff until the designated time. From this designated time onwards, parents are once again legally responsible for the care of their child.

Terms and Conditions of the After-school Care Programme

After-school care

With this letter we wish to inform you about the offer of an After-school Programme at the Akademisches Gymnasium Innsbruck. The registration for after-school care is valid for the entire school year. The binding registration is made with the registration form to be received before **Friday**, **the 14.9.2018**. We ask that you return the registration form to the school secretary no later than **12 midday**. The after-school care takes place on all school days (provided the minimum number of students are registered). We will inform you ahead of time about days should the after-school programme be cancelled.

Location

After-school care takes place in the premises of the former building of the Bundesgymnasium Sillgasse. The pupils are obliged to register at the After-school Care premises immediately following their final formal lesson. The pupils leave the school building independently and go to the former Sillgasse designated rooms. For this, the pupils do not have to cross a road, the premises can be reached in two minutes by foot. By registering for this after-school care programme, you agree that your daughter/son will travel to the premises on his/her own. At the beginning of the school year the children will be accompanied.

Times

In general, we offer after-school supervision from Monday to Thursday from 12:40 pm (or the end of lessons) until 5:00 pm and on Friday until 4:00 pm. The dismissal times can be set individually, lunch is obligatory for all. 12:40 – 13:30 pm individual time or free time 13:30 – 14:25 H Lunch & free time 14:25 – 15:20 pm mandatory time (subject-related time (d, M, E, DAF) or individual time of teaching 15:20 – 17:00 pm (16:00 on Friday) individual time, leisure or creative time (creative, scientific and sport-oriented activities)
